DIRECTIONS:

From 101 South take hwy 25 (Hollister East Pinnacles), continue left on Hwy 25 South for 8.4 miles. Turn right at Hwy 156 (San Juan Bautista exit), continue 3.3 miles to the first stoplight. Turn left on Business Route 156. Turn left at the stop sign. Continue 1 mile. Merge to the right hand turn lane. Field is on the right. Marked Hollister Speedway Go Kart Track. Drive into the fenced off parking area. Do NOT continue on the private dirt roads.

From 101 North exit Hwy 156 Hollister. After the second stoplight merge right towards Hollister. Proceed one mile. Field is on the right.

From I-5 either direction take 152 West towards Gilroy. Exit Hwy 156 Hollister. Continue until second business Route 156 and follow the directions above.
